EQUIPMENT RENTAL AND LIABILITY RELEASE AGREEMENT

TO: JUMPCAMP RENTAL AGREEMENT

1. I accept full responsibility for the care of the rental equipment (the "Equipment") listed on this form and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned by the agreed date.
2. I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer any questions I may have as to the proper use of the Equipment.
3. I also agree to return the Equipment in clean condition to avoid any additional charges. If rental equipment is returned in damaged or dirty condition the renter will be responsible for cleaning and repair costs. Shop rate will be charged (\$35 /hr, \$10 minimum), plus any parts and materials for cleaning or repair. Replacement cost for lost, stolen or destroyed rental equipment is full retail value.

ASSUMPTION OF RISKS

I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGER AND HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the rental of the Equipment, I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that have or may in the future have against JumpCamp and the Manufacturer and distributor of the Equipment, and all of their respective directors, officers, employees, agents, representatives, successors and assigns (all of whom are herein after collectively referred to as "the Releasees") and to the RELEASE THE RELEASEES from any and all liability for any loss, damage, expense, or injury, including death, that I may suffer, or that my next of kin may suffer resulting from or arising out of any aspect of my use of the Equipment, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF WARRANTY ON THE PART OF THE RELEASEES in respect of the design, manufacture, selection, installation, maintenance or adjustment of the EQUIPMENT, or in respect of the provision of or the failure to provide any warnings, directions, instructions, or guidance as to the use of the Equipment;

TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use of the Equipment;

This Agreement shall be effective and binding upon my heir, next of kin, executors, administrators, and representatives in the event of my death or incapacity;

This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction; and

Any litigation involving the parties to this Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.
